**ADDENDUM TO APPLICATION**

Grain Belt Express Clean Line LLC (“Grain Belt Express” or “Company”), pursuant to Section 393.170.1,<sup>1</sup> 4 CSR 240-2.060 and 4 CSR 240-3.105(1)(B), submits this Addendum to its Application for a certificate of convenience and necessity (“CCN”) authorizing it to construct, own, operate, control, manage, and maintain electric transmission facilities within Buchanan, Clinton, Caldwell, Carroll, Chariton, Randolph, Monroe and Ralls Counties, Missouri, as well as an associated converter station in Ralls County.

1. In its Application filed on March 26, 2014, Grain Belt Express provided a list of electric and telephone lines of regulated and non-regulated utilities, as well as other entities that the proposed construction will cross, pursuant to 4 CSR 240-3.105(1)(B)1. See Ex. 3, Application.

2. Exhibit 1 to this Addendum is an amended version of Exhibit 3 to the Application, which includes all of the known railroad tracks crossed by the proposed route, listed by county.
