


Dear Ms. Dale:

Pursuant to Missouri Public Service Commission ("Commission") Rule 4 CSR 240-2.060(5), CenturyTel Long Distance, LLC respectfully requests that the Commission recognize its name change from CenturyTel Long Distance, Inc., reflecting its change in corporate status to a limited liability company.

In accordance with the above-referenced rule, the old name of the certificated, competitive telecommunications company was CenturyTel Long Distance, Inc.; the new name is CenturyTel Long Distance, LLC. Attached hereto is a Certificate of Good Standing for CenturyTel Long Distance, LLC dated March 26, 2007, evidence of the registration of the name change with the Missouri secretary of state.
