Dear Secretary of the Commission:

In January, 2003, the Commission recognized Southwestern Bell Telephone L.P.'s change in its fictitious name from "Southwestern Bell Telephone Company" to "SBC Missouri." By this letter, Southwestern Bell Telephone, L.P. hereby requests that the Commission recognize a change in its fictitious name – from "SBC Missouri" to "AT&T Missouri."

Southwestern Bell Telephone, L.P., recently filed a Registration of Fictitious Name Registration with the Missouri Secretary of State, registering the fictitious name AT&T Missouri, the name under which Southwestern Bell Telephone, L.P. will operate in Missouri. A copy of that registration is attached. Thus, Southwestern Bell Telephone, L.P., d/b/a AT&T Missouri proposes to revise the title pages of the following tariffs to reflect the adoption of these tariffs by Southwestern Bell Telephone, L.P., d/b/a AT&T Missouri:
