

On June 30, 2017, Missouri-American Water Company (MAWC) submitted revised sewer tariff sheets that were assigned Tariff No. YS-2017-0278. On July 12, 2017, the Commission issued its *Notice of Contested Case and Order Suspending Tariff and Delegating Authority*, in which it suspended Tariff No. YS-2017-0278. Since then, MAWC has submitted revised sewer tariff sheets (Tariff No. YS-2018-0153) to comply with the Commissions *Report and Order* and *Order Approving Stipulations and Agreements*. On May 15, 2018, the Commission issued an order authorizing MAWC's compliance sewer Tariff No. YS-2018-0153 to go into effect on May 28, 2018. To avoid confusion, the Commission will reject the sewer tariff sheets MAWC submitted on June 30, 2017.

**THE COMMISSION ORDERS THAT:**

1. The sewer tariff sheets submitted by Missouri-American Water Company on June 30, 2017, and assigned Tariff No. YS-2017-0278 are rejected.
2. This order shall be effective when issued.
