## ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: March 11, 2016

Effective Date: March 21, 2016

On February 22, 2016, the Staff of the Missouri Public Service Commission filed a motion requesting NovaTel LTD, Inc.'s ("NovaTel") certificate of service authority and accompanying tariff to provide interexchange telecommunication services in the State of Missouri be cancelled.

In File Number XA-2009-0399, the Commission granted NovaTel a certificate of service authority to provide interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that NovaTel contacted Staff via letter stating NovaTel was no longer providing service in Missouri and requesting the Commission cancel NovaTel's certificate of service authority. Staff recommends that the Commission cancel the company's certificate of service authority to provide interexchange telecommunications services, and the company's accompanying tariff.

On February 26, 2016, the Commission issued an Order Establishing Time to Respond allowing any parties until March 8, 2016, to file an objection or request a hearing. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on Staff’s motion, the Commission finds that the certificate of service authority and accompanying tariff granted to NovaTel LTD, Inc., shall be canceled.

**THE COMMISSION ORDERS THAT:**

1. The certificate of authority to provide interexchange telecommunications services granted to NovaTel LTD, Inc., in File Number XA-2009-0399, is canceled.
2. NovaTel LTD, Inc.’s tariff, P.S.C. Mo No. 1, is canceled.
3. This order shall become effective on March 21, 2016.
4. This case may be closed on March 22, 2016.
