ORDER APPROVING TARIFF

Issue Date: February 26, 2014

Effective Date: March 4, 2014

On February 14, 2014, Laclede Gas Company ("Laclede"), filed a tariff sheet proposed to become effective March 4, 2014.¹ The tariff sheet reflects a change in Laclede's Purchased Gas Adjustment (PGA) factor as a result of estimated changes in the cost of natural gas for the remainder of the 2013-2014 winter season. The tariff also reflects changes in the L.P. Gas PGA (LPPGA) and in the Capacity Reservation (CR) factor. Laclede's filing will increase the firm PGA factor for the winter season to \$0.54973 per hundred cubic feet (Ccf), from the current firm PGA factor of \$0.50265 per Ccf. This represents an increase of \$0.04708 per Ccf.

The Commission's Staff filed its recommendation on February 21, 2014. Staff recommends the rates be approved on an interim basis, subject to refund pending final Commission decision in File Nos. GR-2014-0121, GR-2013-0253, GR-2012-0133, GR-2011-0055, GR-2010-0138, GR-2008-0387, GR-2008-0140, GR-2006-0288, and GR-2005-0203.

¹ The tariff was inadvertently filed in a prior case, which is File No. GR-2014-0121. The tariff was refiled in the instant case.

The Commission has reviewed the proposed tariff sheet and Staff's recommendation. The Commission finds that the proposed tariff sheet conforms to Laclede's Commission-approved PGA Clause. In addition, because Laclede's PGA clause allows for PGA change filings to take effect on 10-days' notice, good cause has been shown pursuant to Section 393.140(11), RSMo 2000, to permit the tariff to become effective on less than 30-days' notice. The Commission concludes that the proposed tariff sheet should be approved to become effective on March 4, 2014, on an interim basis, subject to refund, pending final Commission decision in File Nos. GR-2014-0121, GR-2013-0253, GR-2012-0133, GR-2011-0055, GR-2010-0138, GR-2008-0387, GR-2008-0140, GR-2006-0288, and GR-2005-0203.

THE COMMISSION ORDERS THAT:

1. The proposed tariff sheet filed on February 14, 2014, by Laclede Gas Company, assigned Tracking Number YG-2014-0324 and bearing an effective date of March 4, 2014, is approved on an interim basis, subject to refund, pending final Commission decision in File Nos. GR-2014-0121, GR-2013-0253, GR-2012-0133, GR-2011-0055, GR-2010-0138, GR-2008-0387, GR-2008-0140, GR-2006-0288, and GR-2005-0203. The tariff sheet approved is:
