ORDER GRANTING EXPEDITED
TREATMENT AND APPROVING TARIFFS

On June 26, 2007, the Commission issued an order allowing Southwestern Bell Telephone, L.P. d/b/a AT&T Missouri to alter its status from a Texas limited partnership to a Missouri corporation. Later that day, AT&T Missouri filed proposed adoption notices and title sheets of its tariffs reflecting its new corporate name, Southwestern Bell Telephone Company d/b/a AT&T Missouri. Along with its tariff filings, AT&T Missouri filed a motion for expedited treatment asking the Commission to approve the tariffs with a June 29, 2007, effective date.

On June 27, 2007, the Commission's Staff filed its recommendation regarding AT&T Missouri's tariff filings and motion for expedited treatment. Staff concludes the tariffs comply with the Commission rule 4 CSR 240-2.060(5), and recommends the Commission approve the tariffs with an effective date of June 29, 2007.

The Commission has reviewed the proposed tariffs and Staff's Recommendation. For good cause shown pursuant to Section 393.140(11), RSMo 2000, the Commission

concludes that the submitted tariffs should be approved to become effective on June 29, 2007.

IT IS ORDERED THAT:

1. The Motion for Expedited Treatment filed by Southwestern Bell Telephone, L.P., d/b/a AT&T Missouri, is granted.

2. The proposed tariffs submitted under Tariff Nos. JI-2007-0940, YI-2007-0941, YI-2007-0942, YI-2007-0943, YI-2007-0944, YI-2007-0945, YI-2007-0946, YI-2007-0947, YI-2007-0948, YI-2007-0949, YI-2007-0950 by Southwestern Bell Telephone, L.P., d/b/a AT&T Missouri for the purpose of reflecting its new corporate name, Southwestern Bell Telephone Company, d/b/a AT&T Missouri, is hereby approved, effective on June 29, 2007.
