ORDER APPROVING COMPLIANCE TARIFF

Issue Date: September 27, 2018

Effective Date: October 13, 2018

The Commission issued an order approving the stipulation and agreement on August 28, 2018, which resolved the issues in this matter. As part of that order, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) was directed to file tariff sheets similar to the exemplar tariff sheets attached to the stipulation and agreement. On September 13, 2018, Ameren Missouri filed tariff sheets (Tariff No. YE-2019-0043) purporting to comply with the Commission's order. The tariff sheets have an October 13, 2018 effective date.

On September 20, 2018, the Staff of the Missouri Public Service Commission (Staff) filed a recommendation. Staff stated it had examined the tariff sheets and found them to be in compliance with the Commission's order and the approved stipulation and agreement. Staff recommended that the tariff sheets be approved. The Commission issued an order setting a September 26, 2018 deadline for responses to Staff's recommendation. No responses were received.

After reviewing the tariffs and the Staff recommendation, the Commission concludes that Ameren Missouri's tariff sheets comply with the Commission's August 28, 2108 order and will approve them.

THE COMMISSION ORDERS THAT:

1. Tariff sheets, bearing Tariff No. YE-2019-0043, filed on September 13, 2018, by Union Electric Company d/b/a Ameren Missouri are approved to become effective on October 13, 2018.
2. This order shall become effective on October 13, 2018.
