- 3. Comtel hereby amends paragraph 10 of its Application, by withdrawing its request for waivers with respect to the following Commission rules: 4 CSR 240-30.010 (2)(C), 4 CSR 240-32.030 4(C), 4 CSR 240-33.030, and 4 CSR 240-35.
- 4. Comtel hereby amends paragraph 12 of its Application to reflect that it is requesting a certificate to provide interexchange services only, for Comtel Telcom Assets LP d/b/a VarTec Solutions, and for Comtel Telcom Assets LP d/b/a Clear Choice Communications. (For the VarTec Telecom and Excel Telecommunications trade names, Comtel continues to request certificates for both local and interexchange services.)

5. Comtel requests Commission approval to adopt the following tariffs of VarTec Telecom, Inc. ("VarTec"), Excel Telecommunications, Inc., VarTec Solutions, Inc., and Clear Choice Communications, and has filed the corresponding cover sheets (Exhibit B) and adoption notices (Exhibit C), as attachments to this submission:
