**ORDER APPROVING FOURTH QUARTERLY  
COST ADJUSTMENT TARIFF**

Issue Date: February 21, 2023

Effective Date: March 1, 2023

The Missouri Public Service Commission is approving the pending tariff sheet, which sets forth the quarterly cost adjustment (“QCA”) for Evergy Missouri West, Inc. d/b/a Evergy Missouri West (EMW) in calendar year 2022, fourth quarter. EMW filed the tariff on January 17, 2023, with an effective date of March 1. On January 17, the Commission issued an order directing Staff to file its recommendation no later than February 16, and for any party wishing to comment on the tariff sheets or Staff’s recommendation to do so no later than February 17. Staff filed its recommendation on February 10, stating that the tariff meets the requirements of EMW’s tariff sheets 6.6 through 6.10. Staff recommends the Commission approve that tariff. No other responses to Staff’s recommendation or EMW’s tariff have been received by the Commission.

The Commission concludes that the tariff complies with EMW’s tariff sheets 6.6 through 6.10, and will support safe and adequate service at just and reasonable rates. The Commission will approve the tariff.

As the tariff filing is unopposed, and so that this tariff may go into effect expeditiously on the requested effective date, the Commission finds it reasonable to make this order effective in less than 30 days.

**THE COMMISSION ORDERS THAT:**

1. Tariff Tracking No. YH-2023-0133 is approved to become effective on March 1, 2023.
