## ORDER APPROVING COMPLIANCE TARIFF SHEETS

Issue Date: January 6, 2023

Effective Date: January 16, 2023

On January 4, 2023,<sup>1</sup> the Commission issued an order approving a stipulation and agreement that resolved all issues regarding Missouri-American Water Company's ("MAWC"'s) revisions to its Water and Sewer Infrastructure Rate Adjustment. In that order, the Commission rejected the tariff sheets MAWC previously filed, and authorized MAWC to file tariff sheets necessary to implement the provisions of the approved stipulation and agreement. MAWC filed compliance tariff sheets on January 4, to be effective on February 3. MAWC asked the Commission to expedite its approval of the tariffs so that they can go into effect on January 16, as provided in the approved stipulation and agreement.

The Commission issued an order on January 5, directing its Staff to file a recommendation regarding MAWC's tariff sheets by 1:00 p.m. on January 6. That order also directed any other party wishing to file a recommendation regarding MAWC's tariff to do so no later than 1:00 p.m. on January 6.

On January 6, Staff filed its recommendation regarding MAWC's compliance tariff. Staff concludes the tariff sheets comply with the approved stipulation and agreement, and

recommends the Commission issue an order approving the compliance tariff sheets to be effective on January 16, as requested by MAWC. No other party filed a recommendation, and no party has filed a response to Staff's recommendation.

The Commission has reviewed the proposed tariff sheets and Staff's recommendation. The Commission concludes the submitted compliance tariff sheets are consistent with the approved stipulation and agreement. The Commission finds good cause pursuant to Section 393.140(11), RSMo to expedite its approval of the tariffs so they can be effective on January 16, consistent with the provisions of the approved stipulations and agreements. The Commission also finds it reasonable to make this order effective in less than thirty days so that the effective date of the order will match the requested effective date of the tariff.

**THE COMMISSION ORDERS THAT:**

1. The proposed water and sewer service tariff sheets submitted under Tariff Nos. YW-2023-0120 and YS-2023-0121 by MAWC are approved, effective on and after January 16, 2023. The specific sheets approved are:
