Enclosed for filing with the Missouri Public Service Commission (Commission) on behalf of Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers), please find in electronic format certain sewer tariff sheets (list attached).

These tariff sheets are being filed to incorporate new, previously unregulated sewer assets of Shelton Estates Sewer Company ("Shelton Estates") and Prairie Heights. LLC ("Prairie Heights") into Confluence Rivers' existing tariff, P.S.C. MO No. 13 pursuant to the Commission's *Order Granting Certificate of Convenience and Necessity* issued in Case No. WA-2021-0425 and Case No. SA-2021-0426.

In relevant part, Confluence Rivers was directed as follows - "Confluence Rivers shall adopt the current existing water and/or sewer rates for . . . Shelton Estates . . . [and] Prairie Heights[.] Confluence Rivers shall submit tariff sheets for . . . Prairie Heights [and] Shelton Estates . . . to become effective before closing on the assets, to include a service area map, service area written descriptions, rates and charges to be included in its EFIS tariffs P.S.C. Mo No. . . . 13." Confluence Rivers does not yet have a scheduled date for closing on the assets of Shelton Estates and Prairie Heights.
