## ORDER APPROVING QUARTERLY COST ADJUSTMENT TARIFF

Issue Date: November 15, 2016 Effective Date: December 1, 2016 The Missouri Public Service Commission is approving the pending tariff sheet ("tariff"), which sets forth the quarterly cost adjustment ("QCA") for KCP&L Greater Missouri Operations Company ("GMO") in calendar year 2016, second quarter. GMO filed the tariff sheet.<sup>1</sup> Staff filed its recommendation,<sup>2</sup> stating that the tariff meets the requirements of GMO's tariff sheets 6.6 through 6.10. Staff recommends that the Commission approve that tariff. The Commission received no other response to the tariff.<sup>3</sup> The Commission concludes that the tariff complies with GMO's tariff sheets 6.6 through 6.10, and will support safe and adequate service at just and reasonable rates, so the Commission will approve the tariff.

1. Tariff No. YH-2017-0054 is approved to become effective on December 1, 2016.
