ORDER APPROVING TARIFF

Effective Date: July 15, 2023

On May 3, 2023, the Commission issued its Report and Order (Order). That Order approved a Stipulation and Agreement (Agreement) that, among other things, authorized Missouri-American Water Company (MAWC) to terminate its pilot low-income program.

On June 15, 2023, MAWC filed Tariff Tracking No. YW-2023-0221, with an effective date of July 15, 2023. MAWC filed that tariff to allow customers who were low-income program participants on May 28, 2023 to continue receiving this benefit through the end of their specific eligibility period, rather than abruptly stopping the program.

On June 26, 2023, Staff filed its Recommendation. Staff stated that it reviewed the tariff sheet, and that Staff recommends the Commission approve it. The Commission received no other responses to the tariff filing or Staff's Recommendation.

The Commission reviewed the tariff filing and Staff's Recommendation, and determines that the filings comply with the Commission's Order. Therefore, the Commission will approve the tariff.

THE COMMISSION ORDERS THAT:
