ORDER GRANTING MOTION FOR EXTENSION OF TIME

Ameren Transmission Company of Illinois (“ATXI”) filed its application on September 15, 2017, and asked for Commission approval no later than January 18, 2018. On November 30, 2017, the Commission issued an Order Setting Procedural Schedule.

On December 12, 2017, due to a party’s withdrawal, the Commission issued an Order Directing Filing, asking the parties to state whether the current procedural schedule could be changed. On December 13, 2017, ATXI filed a Request for Extension of Time to File Response. ATXI states that it needs extra time to determine its position, as well as to consult other parties. Thus, ATXI asks the Commission to allow parties an extension of time to December 19, 2017.

The Commission finds the request reasonable, and will grant it.

THE COMMISSION ORDERS THAT:

1. The Request for Extension of Time to File Response is granted.

2. Parties shall respond to the Commission's December 12, 2017 Order Directing Filing no later than December 19, 2017.

3. This order shall be effective when issued.
