ORDER APPROVING TARIFF

Issue Date: April 25, 2022

Effective Date: May 8, 2022

On April 6, 2022, the Commission issued an *Order Granting Transfer of Assets and Granting Certificate of Convenience and Necessity* authorizing Seven Springs Sewer & Water LLC (Seven Springs) to acquire the sewer assets of TUK, LLC (TUK). Among other things, that order directed Seven Springs to adopt the currently effective tariffs of TUK and to file notice to adopt the TUK sewer tariffs as P.S.C. MO No. 1 to become effective before closing on the assets.

On April 8, 2022, Seven Springs filed a new tariff purporting to be in compliance with the terms of the Commission's April 6th order. On April 11, 2022, Seven Springs filed a substitute tariff that corrected the listed service area. The new tariff carries a 30-day effective date of May 8, 2022, which precedes the intended closing date on the assets of TUK of May 9, 2022. The Commission directed its Staff to file a recommendation regarding the tariff.

Staff filed its recommendation on April 22, 2022, in which it stated that the substitute proposed tariff, as substituted on April 11th, complies with the Commission's April 6th order. Staff recommends approval of the tariff. The Commission will do so.

In order that the tariff can be effective by the date requested, this order will be effective in less than thirty days.

THE COMMISSION ORDERS THAT:

1. The tariff filed by Seven Springs on April 8, 2022, as substituted on April 11, 2022, and assigned Tariff Tracking No. YS-2022-0246, is approved to become effective on May 8, 2022. The tariff sheets approved are:
