Enclosed for filing with the Missouri Public Service Commission ("Commission") are Trans National Communications International, Inc.'s ("TNCI") interexchange telecommunications tariff, Missouri P.S.C. No. 2, local exchange tariff, Missouri P.S.C. No. 3, and switched access tariff, Missouri P.S.C. No. 4.

With this filing, TNCI: 1) replaces its original Missouri P.S.C. No. 1 interexchange tariff to more accurately reflect service terms and conditions, while expanding the number of interexchange service options. This replacement has no impact on subscriber services or corresponding rates; 2) submits new Missouri P.S.C. No. 3 local exchange tariff to introduce the Company's local exchange services under authority originally granted in Case No. CA-2005-0133; and 3) submit new Missouri P.S.C. No. 4 switched access tariff applicable to the provision of switched access services provided to carriers that interconnect to TNCI's network. TNCI's switched access rates are benchmarked to AT&T Missouri's corresponding rates.
