ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: October 3, 2007 Effective Date: October 13, 2007

On July 5, 2007, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority and tariff of R2C Communications, Inc. to provide intrastate interexchange telecommunication service in Missouri.

In Case Number XA-2004-0060, the Commission granted R2C Communications, Inc. a certificate of service authority to provide intrastate interexchange telecommunications service. R2C's tariff, P.S.C. MO. TARIFF NO. 1, was also approved.

Staff's motion states that according to the Missouri Secretary of State's Office, the company is a Kansas corporation listed as "active," but failed to submit its 2007 report. R2C is expected to receive notice that it will be administratively dissolved shortly.

Staff attempted to contact the company at the number provided to the Commission. Staff left numerous voicemail messages and the voicemail message indicated it accepts messages for R2C Communications. Eventually an individual

returned a call was vague about the company's status. Former consultants for the company have indicated they have an impression the company is ceasing operations. Mail sent to the address provided to the Commission has not been returned as undeliverable. E-mail sent to the address provided to the Commission was undeliverable.

Staff's Motion indicates R2C has not submitted a 2006 annual report or a fiscal year 2008 statement of revenue to the Commission. No formal complaints have been filed against the company since the commencement of the Electronic Filing and Information System.

Because R2C cannot be contacted, Staff recommends that the Commission cancel the company's certificate of service authority to provide intrastate interexchange telecommunications service and its accompanying tariff.

Commission Rule 4 CSR 240-3.545(22) requires telecommunications companies to maintain current contact information at the Commission and the company failed to do so.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion and recommendation, the Commission finds that the certificate of service authority and accompanying tariff granted to R2C Communications, Inc. shall be canceled.

IT IS ORDERED THAT:

- 1. The certificate of service authority to provide intrastate interexchange telecommunications service, granted to R2C Communications, Inc. in Case Number XA-2004-0060, is canceled.
 - 2. R2C Communication's tariff, P.S.C. MO. TARIFF NO. 1, is canceled.
 - 3. This order shall become effective on October 13, 2007.
 - 4. This case may be closed on October 14, 2007.
