Pursuant to discussions with Sherri Kohly, the attached tariff sheets revise certain tariff sheets in filing JC-2007-0579, originally filed on February 22, 2007, with a proposed effective date of March 24, 2007. The replacement sheets are as follows:

- Section 1, Original Sheet 3 – corrects Table of Contents page numbering
- Section 1, Original Sheet 8 – adds “Customer Specific Pricing Plan Services” to the Subject Index
- Section 1, Original Sheet 13 – clarifies Obsolete Service Offerings tariff format
- Section 1, Original Sheet 9 – eliminates “Individual Case Basis” from the Subject Index
- Section 2, Original Sheet 12 – replaces “Individual Case Basis” description with a description for “Customer Specific Pricing Plan Services”
- Section 5, Original Sheet 5 – adds language describing service availability in exchanges where the incumbent local exchange company has been declared competitive

Pursuant to discussions with Sherri Kohly, enclosed with this electronic filing are Qwest Communications Corporation's ("QCC") pages to introduce its Missouri Local Exchange Services P.S.C. Tariff and Price List No. 5 and to withdraw its Missouri Access Service P.S.C. Tariff No. 3.

Specifically, QCC is proposing to introduce its Local Exchange Services P.S.C. Tariff and Price List No. 5 with the following products:

1. Introduce Metro Optical Ethernet (MOE) Service in the Local Exchange Tariff and Price List. MOE is a flexible, easy-to-use, transport service that uses established Ethernet transport technology. MOE allows customers to connect multiple enterprise locations within a service area using native Ethernet protocol.
2. Introduce Qwest *QWAVE* Service in the Local Exchange Tariff and Price List. *QWAVE* is a wavelength (Lambda) solution that addresses a range of dense wave division multiplexing (DWDM) transport applications including Metro and Inter-City applications.
3. Introduce Local Business Switched Exchange and Operator Services.

Further, QCC is proposing to withdraw its Access Service P.S.C. Tariff No. 3. The only product currently offered in the Access Service P.S.C. Tariff No. 3 is Qwest Metro Private Line (QMPL) which provides dedicated, point-to-point, private line connections between two customer locations, over a shared, high capacity fiber optic network. With this filing, QCC will move QMPL to the Local Exchange Services P.S.C. Tariff and Price List No. 5.

QCC respectfully requests that the proposed changes outlined above become effective March 24, 2007.
