## ORDER APPROVING HOME ENERGY PERFORMANCE TARIFF

Issue Date: February 20, 2013 Effective Date: March 1, 2013

The Missouri Public Service Commission is approving the Home Energy Performance Tariff ("tariff") for residential natural gas usage. Union Electric Company d/b/a Ameren Missouri filed the tariff on February 1<sup>1</sup> with a motion for expedited treatment. On February 14, the Commission received Staff's recommendation and a response to the tariff from the Missouri Department of Natural Resources. Both favor expedited approval of the tariff. The Commission may approve any tariff without a hearing or any other procedure.<sup>2</sup> The absence of opposition to the tariff constitutes good cause for an effective date less than 30 days from issuance of this order. <sup>3</sup> On review of the filings, the Commission concludes that the tariff will support safe and adequate service at just and reasonable rates. Therefore, the Commission will grant the motion for expedited treatment and approve the tariff.
