Dear Ms. Dale:

On behalf of Algonquin Water Resources of Missouri, LLC ("Algonquin" or "Company"), I am providing herewith to the Missouri Public Service Commission ("Commission") for filing certain tariff sheets in electronic form consisting of revised water and sewer rate schedules, designed to increase the annual water revenue by approximately \$584,390 and the annual sewer revenue by approximately \$309,272, all exclusive of applicable franchise and occupational taxes. The rate schedules bear a date of issue of May 5, 2006, and an effective date of June 4, 2006.

The subject water and sewer systems have not had a rate change since 1998. The proposed rate increases are necessary to address current operating costs and return requirements.
