Dear Judge Woodruff:

On February 6<sup>th</sup>, Brightspeed provided supplemental information to its notice to the Missouri Public Service Commission (“Commission”) of certain name changes filed with the Missouri Secretary of State. It has come to Brightspeed’s attention that there are two items related to the adoption tariffs that need correction.

First, an adoption notice was filed for CenturyTel of Northwest Arkansas. The Commission Staff’s records indicate this entity doesn’t currently have any effective tariffs. The tariff that an adoption notice was filed for had been previously cancelled. That adoption notice was filed in error is hereby withdrawn.

Second, a revised title sheet containing adoption notice language was filed for CenturyTel Broadband Services when only an adoption notice should have been filed. Brightspeed submits the attached substitute tariff adoption notice for CenturyTel Broadband Services.
