ORDER APPROVING TARIFF

On April 18, 2017¹, Union Electric Company d/b/a Ameren Missouri filed the above-referenced tariff. The tariff is meant to modify certain earnings opportunity metrics, and to remove unnecessary references to the MEEIA rule.

The Commission ordered its Staff to file a Recommendation. Staff filed its Recommendation on April 28. Staff states that the proposed tariff sheets are consistent with the Commission's April 13 Order Approving Non-Unanimous Stipulation and Agreement Regarding Use of R&D Funds and Modifications of Measure Incentives in this case.

The Commission also allowed other parties to respond no later than April 28. No other parties responded.

Based on the Commission's review of the tariff and of Staff's verified recommendation, the Commission will approve the tariff.
