Enclosed for filing is P.S.C. MO. No. 7, Fifth Revised Sheet No. 12, which is applicable to the Spire Missouri East operating unit of Spire Missouri, Inc. ("Company").

This revised tariff sheet, which has an issue date of February 13, 2020 and an effective date of March 14, 2020, is being filed to change an Infrastructure System Replacement Surcharge ("ISRS") in accordance with Sections 393.1009, 393.1012 and 393.1015 of the Revised Statutes of Missouri. A full explanation of the surcharge being proposed by the Company is set forth in the *VERIFIED APPLICATION AND PETITION OF SPIRE MISSOURI INC. TO CHANGE AN INFRASTRUCTURE SYSTEM REPLACEMENT SURCHARGE FOR IT'S SPIRE MISSOURI EAST SERVICE TERRITORY*, which was filed February 13, 2020. As proposed herein, the ISRS would increase the typical residential heating customer's bill by \$1.26 per month.

INFRASTRUCTURE SYSTEM REPLACEMENT SURCHARGE
ISRS

Description: The ISRS is designed to recover the costs associated with the Company's eligible infrastructure replacements in accordance with the provisions of Sections 393.1009 to 393.1015, RSMo.

Applicability: In addition to the other charges provided for in the Company's tariff, a monthly ISRS shall be added to each customer's bill for service rendered on and after the effective date of the ISRS.

Schedule of Surcharges: The amount of the ISRS by rate schedule is as follows:
