This filing withdraws the EasyOption services Distinctive Ring and residential Speed Calling 30. There are currently no customers for Speed Calling 30 service and only four customers for Distinctive Ring service in the state. These customers will be migrated to an alternative EasyOption service or given the opportunity to discontinue their service package without penalty prior to June 15, the effective date of this tariff change.
