**ORDER APPROVING TARIFF IN COMPLIANCE**  
**WITH COMMISSION ORDER AND CANCELING TARIFF**

Issue Date: June 17, 2005

Effective Date: June 27, 2005

On October 28, 2004, in Case No. TA-2005-0045, the Commission approved Broadwing Communications, LLC's request to buy Focal Communications Corporation of Missouri's assets and customer base. In that order, the Commission ordered Broadwing to file tariffs in a separate case before offering basic local exchange services to Focal's former customers.

On March 1, 2005, Broadwing filed P.S.C. MO. Tariff No. 1, bearing an effective date of April 15. On March 17, 24, and 29, Broadwing filed substitute tariff sheets. The tariff applied to local, message toll and long-distance end-user communications services. The Commission assigned that tariff number YC-2005-0668, and approved the tariff.

On April 13, the Commission ordered Broadwing to file new tariff sheets. The Commission ordered this because Broadwing already had a P.S.C. MO. Tariff No. 1. On May 13, Broadwing complied, and filed tariff sheets identical to Tariff No. YC-2005-0668. Broadwing named the sheets P.S.C. MO. Tariff No. 3. The Commission assigned those sheets Tariff No. YC-2005-1106. Those sheets bear an effective date of June 27, 2005.

Broadwing asked the Commission to approve P.S.C. MO. Tariff No. 3, and to cancel its P.S.C. MO. Tariff No. 1 that the Commission assigned Tariff No. YC-2005-0668.

On June 16, the Staff of the Commission filed its Recommendation. Staff recommended that the Commission approve P.S.C. MO. Tariff No. 3, and cancel Broadwing's Tariff No. 1 that applies to local, message toll, and long-distance end-user communications services.

The Commission has reviewed the tariff filings and the Staff Recommendation. The Commission determines that the tariff sheets comply with the applicable statutes. The Commission will approve the tariffs. The Commission will also cancel Tariff No. YC-2005-0668.

**IT IS THEREFORE ORDERED:**

1. That the following tariff sheets in Tariff No. YC-2005-0668 issued March 1, 2005, as amended by substitute sheets on March 17, 24, and 29, 2005, are hereby canceled effective June 27, 2005:
