Non-Payment:

Payments not received by the due date will be considered delinquent and will be referred to the Company's credit department for collection. The Credit Department will receive daily updates of payments received on past due accounts.

For payments not received by the due date, we reserve the right to apply a late payment charge equal to 1.5% (or the highest rate permitted under applicable law whichever is less) of the unpaid balance for each month that there remains an unpaid balance. The late payment charge shall be due and payable upon notice to the customer. \*

When any municipality imposes upon the Company any license, occupation, or other similar charge or tax applicable to service by the Company to the customer, or imposes a charge or tax based upon a percentage of gross receipts, net receipts, or other revenues from sale of telephone service by the Company, the charges for local service to customers within such municipality shall be increased by an amount equal to each such customer's proportionate part of any such charge or tax, and such amount shall be shown separately on the customer's bill.

**9. Discontinuance of Service – Residence Service (Continued)**

- G. Held for future use. +
- H. Notwithstanding any other provision of this section, the Company shall postpone discontinuance for at least twenty-one (21) days if service is necessary to obtain emergency medical assistance for a person who is a member of the household where the telephone service is provided and where such person is under the care of a physician. Any person who alleges such emergency, if requested, shall provide the Company with reasonable evidence of such necessity.
- I. Upon the customer's request, the Company shall restore service consistent with all other provisions of this section when the cause of discontinuance has been eliminated.
- J. Payment by personal check may be refused if the customer, within the last twelve (12) months, has tendered payment in this manner and the check has been dishonored, except when the dishonor is due to bank error.
