ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFFS

Issue Date: December 24, 2015 Effective Date: January 4, 2016

On December 7, 2015, the Staff of the Missouri Public Service Commission filed a motion requesting YourTel America, Inc.'s ("YourTel") certificates of service authority and accompanying tariffs to provide competitive basic local and interexchange telecommunication services in the State of Missouri be cancelled. On December 9, 2015, Staff clarified their motion to note YourTel wishes to retain its wireless Eligible Telecommunications Carrier ("ETC") status and only cancel its certificate for wireline ETC status.

In File Numbers TA-99-115 and XA-2003-0118, the Commission granted YourTel certificates of service authority to provide competitive basic local and interexchange telecommunication service in the State of Missouri. The Company's tariffs, P.S.C. Mo Nos. 1, 2, and 3, were also approved.

Staff states in its motion that YourTel contacted Staff stating YourTel no longer wished to provide competitive basic local and interexchange service in Missouri and requested the Commission cancel YourTel's certificates of service authority and accompanying tariffs. Staff recommends that the Commission cancel the company's certificates of service authority to provide competitive basic local and

interexchange telecommunications services, and the company's accompanying tariffs.

On December 11, 2015, the Commission issued an Order Establishing Time to Respond allowing any parties to file an objection or request a hearing no later than December 21, 2015. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificates of service authority and accompanying tariffs granted to YourTel America, Inc., shall be canceled.

THE COMMISSION ORDERS THAT:

- 1. The certificate of authority to provide competitive basic local and interexchange telecommunications services granted to YourTel America, Inc., in File Number TA-99-115 and XA-2003-0118, is canceled.
 - 2. YourTel America, Inc.'s tariff, P.S.C. Mo No. 1, is canceled.
 - 3. YourTel America, Inc.'s tariff, P.S.C. Mo No. 2, is canceled.
 - 4. YourTel America, Inc.'s tariff, P.S.C. Mo No. 3, is canceled.
 - 5. This order shall become effective on January 4, 2016.

4. This case may be closed on January 5, 2016.
