The purpose of this filing is to make the following tariff changes:

- Residential Local Exchange Access Line Monthly Rate will increase by \$2.00 (Current access line rate is \$16.00 increasing to \$18.00)
- Business Local Exchange Access Line Monthly Rate will increase by \$3.00 (Current access line rate is \$18.00 increasing to \$21.00)
- Voice Advantage bundles will increase by \$2.50
- Voice Advantage II bundles will increase by \$2.00
- ExpansionPAK II Bundles will increase by \$3.00 – the components of the total bundle rates will be re-allocated within the bundle due to the business access line rate increase. The total bundle rate will not change and customers will not see an increase in their current bundle rate
