# ORDER APPROVING DEMAND SIDE INVESTMENT MECHANISM RIDER RATE ADJUSTMENT TARIFF

Issue Date: July 19, 2018

Effective Date: August 1, 2018

On June 1, 2018, KCP&L Greater Missouri Operations Company (GMO) filed a tariff, with supporting testimony, to adjust charges related to its approved Demand Side Investment Mechanism (DSIM) rider. The submitted tariff sheet carries an effective date of August 1, 2018. The Commission issued notice of the filing, set an intervention deadline, and directed the Commission's Staff to submit a recommendation. No one filed an application to intervene. Staff submitted its recommendation on July 2, advising the Commission to approve GMO's tariff. No party has filed a response to Staff's recommendation.

Commission Rules 4 CSR 240-20.093(4) and 4 CSR 240-3.163(8) require GMO to make semi-annual adjustments of its DSIM rates to reflect the amount of revenue that has been over or under-collected. The proposed tariff sheet increases the current residential DSIM Rider rate from \$0.00394 per kWh to \$0.00443 per kWh for residential customers and decreases the DSIM Rider rate from \$0.00832 per kWh to \$0.00348 per kWh for nonresidential customers. GMO's requested adjustment would increase the bill of a residential customer by \$.49 for every 1,000 kWhs used. It would decrease a non-residential customer's bill by \$4.84 for every 1,000 kWhs used. The DSIM Rider rate change will decrease GMO's overall revenue collected through residential and non-residential rates by \$6.4 million.

The Commission's rule 4 CSR 240-20.093(4) regarding adjustment of DSIM rates between general rate proceedings states that if the proposed adjustments are in accordance with the rule, Section 393.1075, RSMo, and the previously-approved DSIM, the Commission shall issue an order approving the tariff sheets, and the adjustments shall take effect sixty days after the tariff is filed. The Commission has reviewed GMO's tariff filings and Staff's recommendation and memorandum, and finds that the proposed tariff sheet implementing the DSIM rate adjustment is in compliance with GMO's existing DSIM tariffs and with all applicable statutes and regulations. The Commission will approve GMO's tariff.

## THE COMMISSION ORDERS THAT:

1. KCP&L Greater Missouri Operations Company's tariff filing, assigned Tariff Tracking No. JE-2018-0162, is approved to be effective August 1, 2018, as an interim rate adjustment, subject to prudence review. The tariff sheet approved is:
