ORDER SUSPENDING TARIFF, DIRECTING NOTICE, SETTING DEADLINE, AND DIRECTING STAFF TO FILE RECOMMENDATION

On February 25, 2014, Missouri-American Water Company ("Missouri American") filed a petition to approve a change to its Infrastructure System Replacement Surcharge (ISRS). Missouri American also filed a revised tariff sheet with an effective date of March 27, 2014.¹ Pursuant to Section 393.1006.2(3), RSMo., the Commission is required to issue an order on the application within 120 days. In order to provide an opportunity for the Commission to review the application and for interested parties to intervene, the Commission will suspend the effective date for the proposed tariff sheet and set a deadline for the submission of motions to intervene. The Commission is also statutorily required to publish notice of Missouri-American's request for a change in ISRS.² Therefore, the Commission will direct that notice of the petition be provided.

In addition, the Commission will direct the Staff of the Commission to file a recommendation on Missouri American's petition.

- 1. The proposed tariff sheet, P.S.C. MO No. 13, 4th Revised Sheet No. RT10, Canceling 3rd Revised Sheet No. RT10 (identified with Tracking No. YW-2014-0329) is suspended until June 25, 2014.
- 2. The Data Center of the Missouri Public Service Commission shall serve notice of this order with the County Commission of St. Louis County.
- The Information Officer of the Missouri Public Service Commission shall notify the media serving St. Louis County and the General Assembly representing
 St. Louis County of this order.
- 4. Applications to intervene shall be filed no later than March 27, 2014. Such applications may be filed through the Commission's Electronic Filing and Information System (EFIS).
- 5. The Staff of the Commission shall file a recommendation on the petition no later than April 9, 2014.
 - 6. This order shall become effective upon issuance.
