On October 17, 2013¹, Missouri Gas Energy, a division of Laclede Gas Company ("MGE"), filed a tariff sheet proposed to become effective November 1. MGE field a substitute tariff sheet on October 23 to correct an error in the sheet designation.

The tariff sheet reflects a change in MGE's Purchased Gas Adjustment (PGA) factor and its Actual Cost Adjustment (ACA) factor as a result of estimated changes in the cost of natural gas for the upcoming 2013-2014 heating season. MGE's filing will decrease the PGA factor to \$0.55962 per hundred cubic feet (Ccf), from the current PGA factor of \$0.56529 per Ccf.

The Commission's Staff filed its recommendation on October 24. Staff recommends the rates be approved on an interim basis, subject to refund pending final Commission decision in this case.

The Commission has reviewed the proposed tariff sheet and Staff's recommendation. The Commission finds that the proposed tariff sheet conforms to MGE's Commission-approved PGA Clause. In addition, because MGE's PGA clause allows for PGA change filings to take effect on 10-days' notice, good cause has been shown pursuant

to Section 393.140(11), RSMo 2000, to permit the tariff to become effective on less than 30-days notice. The Commission concludes that the proposed tariff sheet should be approved to become effective on November 1, on an interim basis, subject to refund, pending final Commission decision in this case.

THE COMMISSION ORDERS THAT:

1. The proposed tariff sheet filed on October 17, 2013, as substituted on

October 23, 2013, by Missouri Gas Energy, a division of Laclede Gas Company, assigned

Tracking Number YG-2013-0182, and bearing an effective date of November 1, 2013, is

approved on an interim basis, subject to refund, pending final Commission decision in this

case. The tariff sheet approved is:
