**ORDER FURTHER SUSPENDING TARIFF**

Effective Date: August 3, 2018

Union Electric Company d/b/a Ameren Missouri filed a revised tariff on March 7, 2018, as part of its plan to offer a pilot subscriber solar program. That tariff filing was assigned Tariff No. YE-2018-0110. The Commission suspended that tariff until August 4 to allow time to consider Ameren Missouri's proposal. On May 14, the parties filed a unanimous stipulation and agreement, which Public Counsel did not sign, but does not oppose. That stipulation and agreement provides that in approving the stipulation and agreement, the Commission should reject Tariff No. YE-2018-0110. Ameren Missouri would then file an agreed-upon tariff in its place.

An order approving the stipulation and agreement was discussed by the Commission at its June 13 agenda meeting, but was withdrawn after the Commissioners identified some inconsistencies that the parties agreed to correct. The parties have not yet submitted a corrected stipulation and agreement.

Unless the Commission takes action to further suspend Tariff No. YE-2018-0110, which by terms of the stipulation and agreement should not be approved, it will go into effect when its term of suspension ends on August 4. Therefore, the Commission will

suspend that tariff for an additional thirty days to allow time to address the stipulation and agreement of the parties.

**THE COMMISSION ORDERS THAT:**

1. The tariff submitted by Union Electric Company d/b/a Ameren Missouri on March 7, 2018, assigned Tariff No. YE-2018-0110, previously suspended until August 4, 2018, is further suspended until September 3, 2018.
2. This order shall be effective when issued.
