ORDER RELIEVING STAFF FROM FILING A RECOMMENDATION AND DIRECTING FILING

Ameren Missouri and Staff filed a *Joint Motion to Relieve Staff from Filing a Recommendation*¹ (“motion”).

The motion asks that Staff be relieved of the order to file a recommendation on the pending tariff. That tariff’s proposed effective date is November 22.² In support of the motion, Ameren Missouri and Staff state that the parties are continuing their discussions, including the service of and compliance with data requests, and a technical conference scheduled for July 22.

The Commission will relieve Staff of the obligation to file a recommendation and direct the filing of a progress report.

THE COMMISSION ORDERS THAT:

1. The *Joint Motion to Relieve Staff from Filing a Recommendation* is granted as set forth in the body of this order.
2. No later than July 25, 2016, Staff shall file a report on the progress of negotiations, which shall include further procedural suggestions.
