# ORDER REJECTING TARIFF

Issue Date: September 11, 2018 Effective Date: September 11, 2018

On September 7, 2018, Union Electric Company d/b/a Ameren Missouri filed a compliance tariff, Tariff No. YE-2019-0042. Subsection 393.140(11), RSMo, states, in part:

Unless the commission otherwise orders, no change shall be made in any rate or charge, or in any form of contract or agreement, or any rule or regulation relating to any rate, charge or service, or in any general privilege or facility, which shall have been filed and published by a gas corporation, electrical corporation, water corporation, or sewer corporation in compliance with an order or decision of the commission, except after thirty days' notice to the commission and publication for thirty days as required by order of the commission, which shall plainly state the changes proposed to be made in the schedule then in force and the time when the change will go into effect. The commission for good cause shown may allow changes without requiring the thirty days' notice under such conditions as it may prescribe.<sup>1</sup>

The tariff sheets submitted by Ameren Missouri were issued on September 7, 2018, with an effective date of October 1, 2018. Thus, the tariff submission is deficient because it does not have a 30-day effective date and no request for expedited treatment or showing of good cause has been made. Therefore, the Commission rejects the tariff as submitted. Ameren Missouri may submit corrected compliance tariff sheets with an appropriate effective date and it may request expedited treatment if there is good cause for those tariff sheets to become effective in less than thirty days.
