**ORDER APPROVING TARIFF IN COMPLIANCE
WITH COMMISSION ORDER**

Issue Date: June 16, 2022

Effective Date: July 1, 2022

On May 12, 2022, the Commission issued an order approving a stipulation and agreement that authorized Evergy Missouri Metro and Evergy Missouri West (Evergy) to extend its Missouri Energy Efficiency Investment Act Cycle 3 an additional year, under specific conditions. The Commission ordered Evergy to file tariff sheets in compliance with that order. On June 1, 2022, Evergy filed tariff sheets to comply with that order. Those tariff sheets bear an effective date of July 1, 2022.

The Commission ordered its Staff to file a recommendation on the compliance tariff sheets by June 15, 2022. Other parties were also given until that date to file any comments concerning the compliance tariff sheets. Staff timely filed its recommendation advising that the tariff sheets comply with the order and recommended their approval. No other comments were received.

After reviewing the compliance tariff sheets and Staff’s recommendation, the Commission finds the tariff sheets comply with the Commission’s order. So that Evergy can implement the compliance tariff sheets on their effective date, the Commission finds it reasonable to make this order effective in less than thirty days.

THE COMMISSION ORDERS THAT:

1. The following tariff sheets, submitted by Evergy Missouri Metro and Evergy Missouri West, assigned Tracking Nos. YE-2022-0268 and YE-2022-0269, are approved to become effective on and after July 1, 2022:
