ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: August 1, 2012

Effective Date: August 11, 2012

On July 18, 2012, the Staff of the Missouri Public Service Commission filed a motion requesting Airnex Communications, Inc. ("Airnex") certificate of service authority and accompanying tariff to provide intrastate interexchange telecommunication services in the State of Missouri be cancelled.

In File Number TA-99-355, the Commission granted Airnex a certificate of service authority to provide intrastate interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that Airnex has failed to respond to Staff filings and Staff has been unsuccessful in contacting Airnex via U.S. mail and telephone. Airnex is deficient in the filing of the Company's annual report for the calendar years 2007 through 2011, and the 2011 Statement of Revenue. Staff recommends that the Commission cancel the company's certificate of service authority to provide intrastate interexchange telecommunications services, and the company's accompanying tariff.

On July 18, 2012, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than July 30, 2012. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on Staff’s motion and because Airnex did not object to Staff’s motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Airnex Communications, Inc., shall be canceled.

IT IS ORDERED THAT:

1. The certificate of authority to provide intrastate interexchange telecommunications services granted to Airnex Communications, Inc., in File Number TA-99-355, is canceled.
2. Airnex Communications, Inc.’s tariff, P.S.C. Mo No. 1, is canceled.
3. This order shall become effective on August 11, 2012.

4. This case may be closed on August 12, 2012.
