On December 12, 2022, Missouri-American Water Company (Missouri-American) filed the above-referenced application. The Commission approved the application on May 18, 2023. In the order approving the application, the Commission ordered Missouri-American to file a tariff.

Missouri-American filed a tariff on May 19, 2023. That tariff bears an effective date of June 18, 2023. However, Missouri-American asks for expedited treatment so that the tariff may become effective on June 1, 2023, or as soon thereafter as is practicable.

The Commission will order expedited responses.

### THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a Recommendation or alternative pleading no later than May 24, 2023.

2. Any other responses shall be filed no later than May 25, 2023.

3. This order shall be effective when issued.
