ORDER APPROVING TARIFF FILINGS IN COMPLIANCE WITH COMMISSION ORDER

On October 15, 2018, Elm Hills Utility Operating Company, Inc. filed tariff sheets under Tariff Tracking No. YS-2019-0065 in compliance with the Commission's *Order Granting Certificate of Convenience and Necessity and Granting Waiver* issued on September 12, 2018. The tariff sheets were substituted on October 17, 2018. The submitted tariff sheets bear a proposed effective date of November 14, 2018, but the company has requested expedited treatment so the tariff sheets become effective on the date of closing, which is October 31, 2018.

On October 18, 2018, the Commission's Staff filed a recommendation that the Commission approve the compliance tariffs. No other party filed a response or objected to approving the tariff sheets or granting the motion. The Commission has reviewed the tariff filings and Staff's recommendation and concludes that the tariffs should be approved and the unopposed motion for expedited treatment should be granted.

THE COMMISSION ORDERS THAT:

1. Elm Hills Utility Operating Company, Inc.'s *Motion for Expedited Treatment* filed on October 15, 2018, is granted.

2. The tariff sheets filed by Elm Hills Utility Operating Company, Inc. on October 15, 2018 in Tariff Tracking No. YS-2019-0065, as substituted, are approved to become effective on October 31, 2018.

3. This order shall become effective on October 31, 2018.

4. This file shall be closed on November 1, 2018.
