## ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: January 19, 2007 Effective Date: January 29, 2007

On January 8, 2007, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority and accompanying tariff of Buzz Telecom, Corporation, a company that has been authorized to offer intrastate interexchange telecommunications services by the Commission.

In Case Number XA-2003-0231, the Commission granted Buzz Telecom a certificate to provide intrastate interexchange telecommunications services. In the same case, Buzz Telecom's tariff, P.S.C. Mo No. 1, was also approved.

Staff's motion states that the company's president, Kurtis Kintzel, indicated in an electronic mail to Public Service Commission Counsel, David Meyer, that Buzz Telecom is no longer providing telecommunications services in Missouri and requested the cancellation of the company's certificate and tariff. Buzz Telecom has no customers using the service that was to be provided under that name, and does not intend to pursue that line of business. In addition, Buzz

Telecom failed to file its annual registration report according to the Missouri Secretary of State's Office, and its authorization to do business in the State of Missouri was revoked on March 29, 2006. No Complaints have been filed against Buzz Telecom since the commencement of the Electronic Filing and Information System. Staff recommends that the Commission cancel the company's certificate of service authority and accompanying tariff, P.S.C. Mo No. 1, to provide intrastate interexchange telecommunications services.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion and the president of Buzz Telecom's request to cancel the certificate and tariff, the Commission finds that the certificate of service authority and accompanying tariff granted to Buzz Telecom, Corporation, shall be canceled.

## IT IS ORDERED THAT:

- 1. The certificate of authority to provide intrastate interexchange telecommunications services granted to Buzz Telecom, Corporation, in Case Number XA-2003-0231, is canceled.
  - 2. Buzz Telecom's tariff, P.S.C. Mo No. 1, is canceled.
  - This order shall become effective on January 29, 2007.

4. This case may be closed on January 30, 2007.
