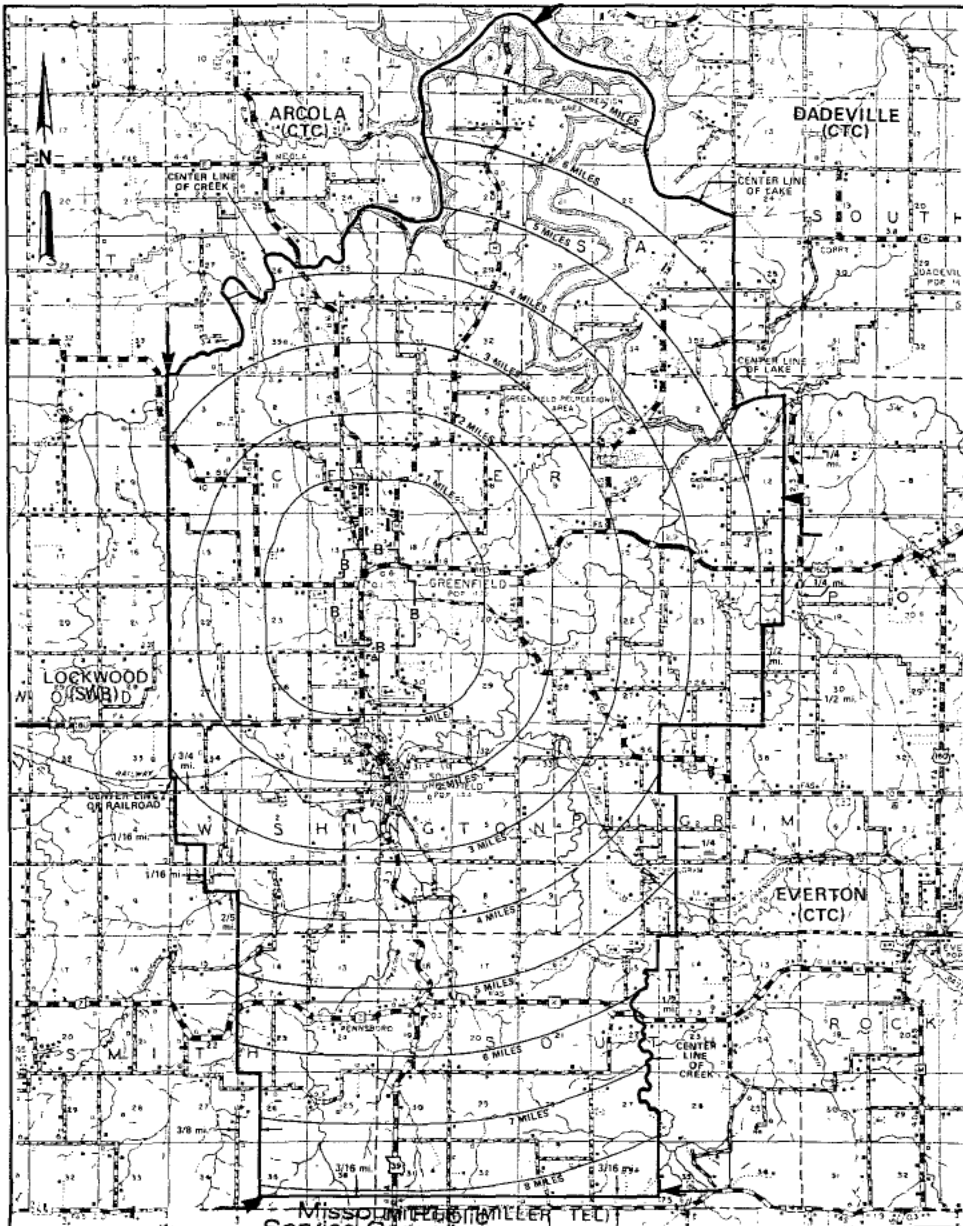
GREENFIELD EXCHANGE

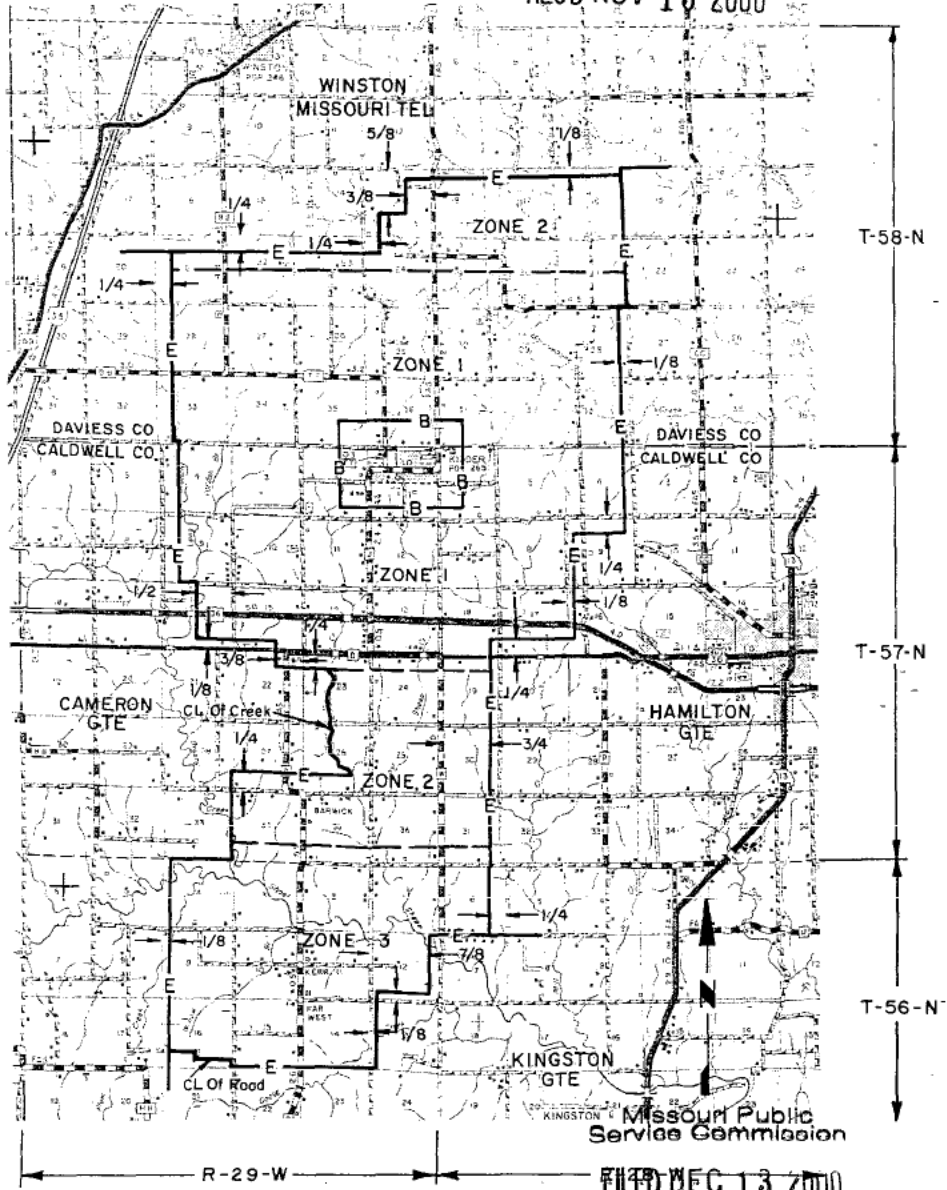
KIDDER EXCHANGE
