**ORDER SUSPENDING TARIFF**

On August 5, 2013, KCP&L Greater Missouri Operations Company ("GMO") filed a Request For Approval Of Tariff And For Variance. GMO specifically requested a variance from certain portions of the Commission's Electric Utility Renewable Energy Standard Requirements and the Commission's Net Metering Rules. The Commission issued an order giving interested parties until August 21, 2013 to intervene or submit objections to GMO's revised tariff sheets. The Commission received timely applications to intervene and Brightergy, LLC filed a motion to suspend GMO's revised tariffs. Commission's Staff filed a recommendation to approve certain tariff sheets while suspending others.

The Commission will suspend the tariff.

1. The tariff submitted on August 5, 2013, by KCP&L Greater Missouri Operations Company under Tariff File No. JE-2014-0059, is suspended until December 26, 2013, unless otherwise ordered by the Commission:
