## **ORDER APPROVING COMPLIANCE TARIFF**

On December 16, 2015, the Commission issued an Order Approving Transfer of *Utility Assets* granting Foxfire Utility Company ("Foxfire") authority to transfer certain water utility assets. In the Order, the Commission directed Foxfire to notify the Commission upon the completion of the transfer of water assets to its Spring Branch system and to submit revised tariff sheets removing text, rates, and references to the Spring Branch or Benton County service area.

On January 28, 2016, Foxfire notified the Commission that the transfer of the Spring Branch system was completed on January 25. Foxfire submitted revised tariff sheets (tracking Nos. JW-2016-0202, JW-2016-0203, JW-2016-0206, JW-2016-0207, YW-2016-0208, YW-2016-0209, YW-2016-0210, YW-2016-0211<sup>1</sup>) on February 11. On March 7, the Commission's Staff filed a recommendation to approve Foxfire's tariff filing. Staff states that a review of the tariff submission was conducted and that the tariff sheets are in compliance with the Commission's order.

The Commission will approve the compliance tariff sheets to go into effect on the proposed effective date of March 12.
