ORDER APPROVING QUARTERLY COST ADJUSTMENT TARIFF

Issue Date: February 16, 2017

Effective Date: March 1, 2017

The Missouri Public Service Commission is approving the pending tariff sheet ("tariff"), which sets forth the quarterly cost adjustment ("QCA") for KCP&L Greater Missouri Operations Company ("GMO") in calendar year 2016, fourth quarter. GMO filed the tariff on January 13, 2017, with an effective date of March 1, 2017. Staff filed its recommendation on February 16, stating that the tariff meets the requirements of GMO's tariff sheets 6.6 through 6.10. Staff recommends the Commission either approve that tariff, or allow it to go into effect by operation of law. The Commission received no other response to the tariff.¹

The Commission concludes that the tariff complies with GMO's tariff sheets 6.6 through 6.10, and will support safe and adequate service at just and reasonable rates. The Commission will approve the tariff.

THE COMMISSION ORDERS THAT:

1. Tariff No. JH-2017-0146 is approved to become effective on March 1, 2017.


