On July 15, 2019, Spire Missouri West, an operating unit of Spire Missouri, Inc. ("Company") filed the enclosed P.S.C. MO. No. 8, Third Revised Sheet No. 12, in Appendix A of its *Verified Application and Petition of Spire Missouri Inc. to Change an Infrastructure System Replacement Surcharge for Its Spire Missouri West Service Territory* ("Application and Petition").

This revised tariff sheet, which has an issue date of July 15, 2019 and an effective date of August 14, 2019, was filed to change an Infrastructure System Replacement Surcharge ("ISRS") in accordance with Sections 393.1009, 393.1012 and 393.1015 of the Revised Statutes of Missouri. A full explanation of the surcharge being proposed by the Company is set forth in the Application and Petition. The ISRS rates in the attached tariff sheet were derived from the revenue requirement calculation included in Appendix A, Schedule 8 of the aforementioned Application and Petition. As proposed herein, the ISRS would increase the typical residential heating customer's bill by \$0.93 cents per month.

Please bring this filing to the attention of the appropriate Commission personnel.

INFRASTRUCTURE SYSTEM REPLACEMENT SURCHARGE
ISRS

Description: Rate ISRS is designed to recover the costs associated with the Company's eligible infrastructure replacements in accordance with the provisions of sections 393.1009, 393.1012 and 393.1015, RSMo.

Applicability: Rate ISRS is applicable to each customer billing for service during the effectiveness of the ISRS rate element.

ISRS Rate Element: In addition to the other charges provided for in the Company's tariff, a monthly ISRS Rate Element shall be added to each bill for service on and after the effective date of the ISRS rate. The amount of the ISRS Rate Element, by customer class, is as follows:

Residential	\$2.72	per month	*
Small General Service	\$4.08	per month	*
Large General Service	\$17.71	per month	*
Large Volume Service	\$148.99	per month	*
Intrastate Transportation Service	\$148.99	per month	*

* - indicates new rate
