#### Dear Secretary:

Attached for electronic filing is a revision to the P.S.C. MO Tariff No. 1 (Interexchange) submitted on behalf of CenturyTel Long Distance, LLC d/b/a CenturyLink Long Distance.

This electronic filing proposes text changes for Basic Business Unlimited for business customers and Simple Choice Unlimited for residential customers' bundled service options available under these plans. Specifically, this filing removes from this tariff, those charges applicable for the local and interstate long distance provided by CenturyLink. This change is made for standardization to mirror the rate presentation used for similar bundled services provided by other CenturyLink affiliates.

This filing also includes the removal of language pertaining to an early termination fee for customers with 4-10 lines, who cancel their service prior to twelve months after subscribing to the service. That condition was applicable when Basic Business Unlimited was offered as a promotion, prior to its availability as a general offering. Deletion of this regulation does not impact current customers.

The Company respectfully requests an effective date of December 6, 2013.
