Attached for electronic filing is a PDF copy of revisions to our McLeodUSA Telecommunications Services, Inc.'s ("McLeodUSA") Intrastate Access Services Tariff P.S.C. MO No. 6 ("Tariff No.6"). In this filing, McLeodUSA is adding the "d/b/a PAETEC Business Services" to McLeodUSA (Sheet Nos. Title Page, 1, 5 and 7); and adding the Waivers that were accidentally omitted from the replacement filing in 2006 (Sheet No. 1). Sheet Nos. 8 and 9 were modified due to space limitations.

In Case No. TN-2008-0262, effective March 22, 2008, the Missouri Public Service Commission ("MPSC") recognized the adoption of the fictitious corporate name and approved the "d/b/a PAETEC Business Services" changes to McLeodUSA Local Tariff No. 4 and McLeodUSA Long Distance Tariff No. 5 (Tariff Nos. JC-2008-0478 and JX-2008-0479, respectively). However, McLeodUSA omitted filing those same fictitious corporate name changes to the McLeodUSA Intrastate Access Tariff No. 6. Thus, McLeodUSA is now submitting the proposed tariff changes to incorporate the "d/b/a PAETEC Business Services" to the McLeodUSA Tariff No. 6.

In accordance with the Missouri Public Service Commission Rule 4 CSR 240-2.060(5), McLeodUSA Telecommunications Services, Inc has made a name change to McLeodUSA Telecommunications Services, Inc. d/b/a PAETEC Business Services. Attached are the Adoption Letter and a copy of the "Registration of Fictitious Name" filed with the Secretary of State for the state of Missouri. The Adoption Letter includes the original certification number, TA-98-288.

Also, McLeodUSA is submitting a copy of the notice to business customers of the Merger between McLeodUSA and PAETEC. The attached notice, via bill message, was distributed beginning February 16, 2008 and completed on March 11, 2008.

This tariff has an issue date of May 21, 2008 and an effective date of June 21, 2008. Thank you for your assistance in processing this filing.
