On September 28, 2021, Union Electric Company d/b/a Ameren Missouri filed notice, pursuant to Commission Rule 20 CSR 4240-4.017(1), indicating its intent to file an application with the Commission for approval of a certificate of convenience and necessity regarding a renewable generation facility. The Commission's rule provides that if the application is not filed within 180 days, the noticed case shall close.

More than 180 days have passed since Ameren Missouri filed its notice and by terms of the regulation, File No. EA-2022-0089 has closed.
