**ORDER APPROVING TARIFF FILINGS IN COMPLIANCE WITH  
COMMISSION ORDER**

On March 19, 2018, Missouri-American Water Company filed tariff sheets in compliance with the Commission’s *Order Approving Transfer of Assets* issued on March 7, 2018. The submitted tariff sheets bear a proposed effective date of April 18, 2018, but the company has requested expedited treatment so the tariff sheets become effective on the date of closing, which is April 3, 2018.

On March 22, 2018, the Commission’s Staff filed a recommendation that the Commission approve the compliance tariffs and grant the motion for expedited treatment. No other party filed a response or objected to approving the tariff sheets or granting the motion. The Commission has reviewed the tariff filings and Staff’s recommendation and concludes that the tariffs should be approved and the unopposed motion for expedited treatment should be granted.

**THE COMMISSION ORDERS THAT:**

1. Missouri-American Water Company’s *Motion for Expedited Treatment* filed on March 19, 2018, is granted.
