## **ORDER GRANTING APPLICATION**

The Missouri Public Service Commission is granting the application for recognition of the following name change:

From: Norlight, Inc.

To: Windstream Norlight, Inc.

The Commission is also approving the tariff sheets filed with the application.

On June 22, 2011, the Commission received the application with tariff sheets. On July 12, 2011, the Commission's staff ("Staff") filed its recommendation favoring the application and recommending that the tariffs take effect by operation of law or be approved. Because no party disputes the application, no law requires a hearing before granting the application, so the Commission convened no hearing and bases its findings on the verified filings.<sup>1</sup>

Therefore, the Commission will grant the application, recognize the name change, and approve the tariffs.
